Like many other health conditions, suicide is generally preventable. Research has shown that *suicidality* is a diagnosable and treatable mental health condition. Suicide shares risk factors with substance abuse, bullying and harassment, traumatic events (including sexual abuse, violence, post-traumatic stress), as well as other mental health and societal conditions. To the degree that community members, providers and consumers of mental health services, and institutions can be actively involved in learning about, implementing, and providing suicide prevention activities, we can all help to prevent suicide.

The Vermont Suicide Prevention Center (VTSPC) is a statewide resource fostering a sustainable approach to suicide prevention in Vermont. Under the advisement of the Vermont Suicide Prevention Coalition, the VTSPC's mission is to create health-promoting communities in which schools, educational institutions, public and private agencies, and people of all ages and backgrounds have the knowledge, attitudes, skills and resources to reduce the risk of suicide.

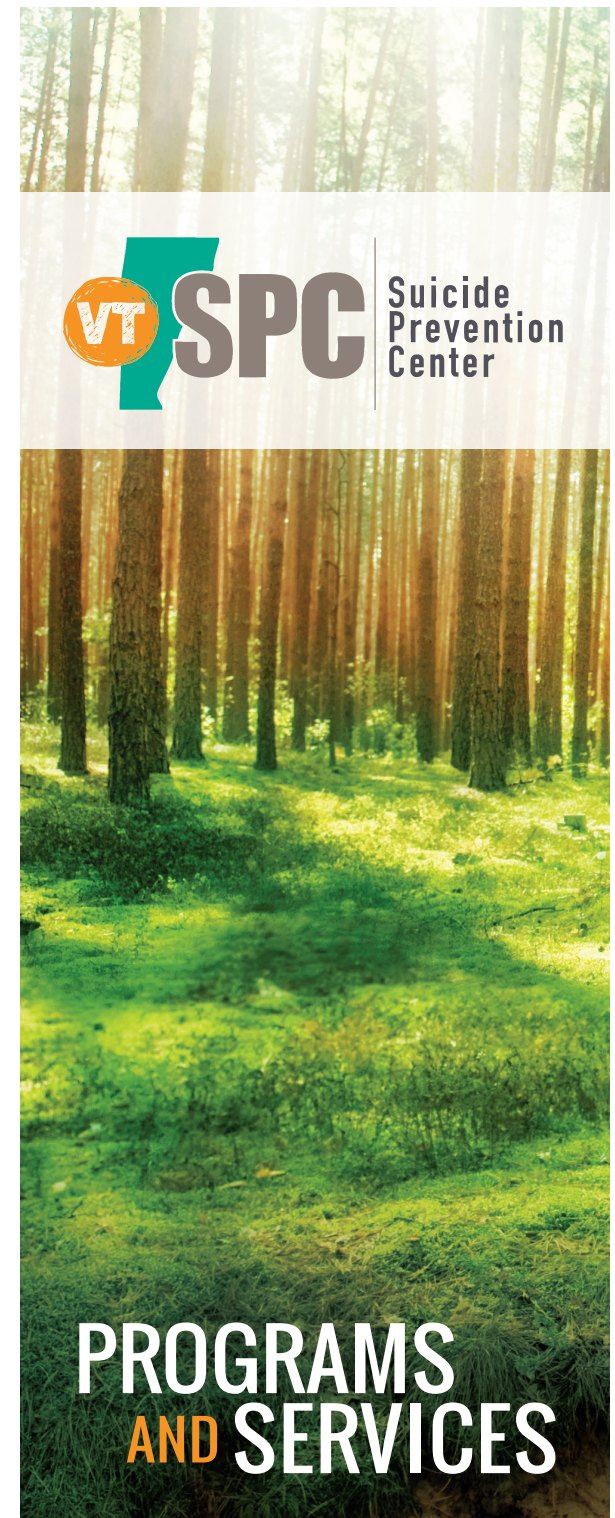

## Our Work

- Promotes mental health and emotional resilience in Vermont through collaborations involving public education and statewide prevention policies.

- Involves youth and adults in suicide prevention activities, including public education for developing coping skills and help-seeking behaviors.
- Equips youth and adult gatekeepers with the knowledge and skills necessary to respond effectively to signs of distress, and intervene with those showing warning signs of suicide.
- Teaches strategies for early identification of mental health conditions and builds pathways for care and recovery.
- Encourages access to primary care and mental health services providing effective intervention, treatment and follow-up.
- Supports the use of data and personal stories to inform suicide prevention in Vermont.
- Provides strategic tools for developing suicide prevention programs, implementing interventions, and promoting policies to prevent suicide.
